AAP 2025 Annual Meeting Promotion OFFICIAL RULES

NO PURCHASE NECESSARY

- 1. **ELIGIBILITY**: The AAP 2025 Annual Meeting Promotion (the "Annual Meeting Promotion") is open only to individuals who are: (a) legal residents of one of the 50 United States or the District of Columbia; (b) 18 years of age or older, and (c) current AAP members. Employees of the AAP, exhibitors and their employees, as well as the immediate family (spouses/partners, parents, siblings, and children) and household members of each such individual are not eligible. The Annual Meeting Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.
- 2. **PROMOTION PERIOD**: The entry period for the prize drawing for the Annual Meeting Promotion is 1 p.m. Pacific Standard Time on Friday, November 1, 2024, through 12 p.m. Pacific Standard Time on Sunday, November 3, 2024 ("Promotion Period").
- 3. **HOW TO ENTER**: The AAP will automatically enter all eligible individuals who during the Promotion Period: a) register for the AAP 2025 annual meeting onsite at the 2024 annual meeting or b) enter to win via email. Eligible individuals must register for AAP 2025 annual meeting or email their names to meetings@perio.org no later than 12 p.m. Pacific Time, Sunday, November 3, 2024, to be entered into the drawing.
- 4. **PRIZES**: One entrant will be selected to receive a prize for a total of one winner. The prize package will consist of one (1) hooded sweatshirt, one (1) hat, one (1) pair of socks (value of CAD\$160), and two (2) CN Tower passes (value of CAD\$100). No cash or other substitution is allowed except by the Sponsor who may substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if any advertised prize becomes unavailable, as determined by Sponsor in its sole discretion. If applicable, prizes will be reported as income to the winner and the winner will be responsible for payment and reporting of all applicable taxes associated with the receipt of a prize. Limit of one prize per individual.
- 5. **PRIZE DRAWINGS**: The drawing for the prize will take place by 5 p.m. Central Time, Friday, November 8, 2024, after the close of the Promotion Period. Sponsor will select the name of the potential winner in a random drawing of all entries received by the close of the Promotion Period. Winner does not need to be present to win. Sponsor and/or AAP will notify the potential winner by email at the address provided on the annual meeting registration form or, for entries received by email, the address provided in that email. If no response is received from the potential winner within five business days, the next individual will be selected at random until a potential winner is selected. The manner and timing of notification may be modified as the Sponsor deems appropriate in its sole and absolute discretion.
- 6. **ODDS**: The odds of being selected for each prize depend on the number of eligible entries received.
- 7. **REQUIREMENTS**: If it is determined by Sponsor, in its sole and absolute discretion, that the potential winner is not eligible to participate or receive a prize in accordance with these Official Rules, an alternate entrant shall be selected in his/her place in a random drawing of all other entries received. Each winner is responsible for all federal, state and local taxes on the value of the prize awarded.
- 8. **AGREEMENT WITH OFFICIAL RULES**: Participation in the Annual Meeting Promotion constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor, which are final and binding. The prize award is contingent upon the potential winner's fulfillment of all requirements set forth in these Official Rules.
- 9. **GENERAL CONDITIONS**: In the event that the operation of the Annual Meeting Promotion is impaired in any way for any reason, including, but not limited to, fraud, virus, or other technical problem, Sponsor may, in its sole discretion, either: (a) suspend the Annual Meeting Promotion to address the impairment and then resume the Annual Meeting Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) award the prize at random from among the eliqible entries received up to the time of the impairment.

Sponsor reserves the right in its sole and absolute discretion to disqualify any individual it finds to be tampering with the operation of the Annual Meeting Promotion or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 10. **RELEASE AND LIMITATIONS OF LIABILITY**: By participating in the Annual Meeting Promotion, entrants agree to release and hold harmless Sponsor, its officers, trustees, employees, agents, contractors and assigns (the "Released Parties"), from and against any claim or cause of action arising out of participation in the Annual Meeting Promotion or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Annual Meeting Promotion; (b) printing errors; (c) errors in the administration of the Annual Meeting Promotion or the processing of entries; or (d) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Annual Meeting Promotion, receipt or use of any prize. Entrants further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Annual Meeting Promotion, and in no event shall the Released Parties be liable for attorney's fees. Entrants waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.
- 11. **DISPUTES**: Except where prohibited, entrants agree that any and all disputes, claims and causes of action arising out of, or connected with, the Annual Meeting Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Illinois. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligations of Sponsor in connection with the Annual Meeting Promotion, shall be governed by, and construed in accordance with, the laws of the State of Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Illinois.
